# Contract Description:

Total length of the road under this Contract is 8.91 km, 4.31 km of which are outside localities and 4.6 km of which-through localities. There are two patterns of existing road pavement: one of crushed stone and the other of asphalt concrete. The main prevailing defects are: transverse and longitudinal cracks, rutting, blocks of cracks and alligator cracks, undulations, ravelling and damaged edges.

There are 9 existing culverts on this Corridor, some of them shall be repaired, the other shall be replaced; there is one existing bridge which shall be repaired.

Traffic safety shall be improved through construction of intersections, installation of road signs, metallic parapets, marker posts and road marking.
