Contract Description:

Total length of the sections under the Contract 1 is 13.10 km.

There are two different patterns for rehabilitation of the pavement which are the following:

- Asphalt concrete laid on base course of asphalt concrete and base course of crushed stone.
- total reconstruction including asphalt concrete laid on base course of asphalt concrete, base course of crushed stone and ballast material

There are 343 m of culverts on this road section that should be repaired/build. Traffic safety shall be improved through construction of intersections, installation of road signs, metallic parapets, marker posts and road marking.
