Deschiderea publică a Ofertelor

Ca urmare a lansării procedurii de achiziție publică Nr. LRIP/W4/01-04 și publicării Invitației pentru depunerea Ofertelor, 21 companii (Anexa nr. 5) și-au exprimat interesul de participare, fiindu-le puse la dispoziție Documentele de Licitare.

Comitetul de Evaluare a desfășurat la data de 15 martie 2019, ora locală 16:05, la sediul Î.S.„Administrația de Stat a Drumurilor”, deschiderea Ofertelor depuse până la termenul limită stabilit.

Reprezentantul ASD a prezentat membrii Comitetului de Evaluare și a specificat scopul ședinței și modul de derulare a acesteia. De asemenea, s-a precizat că licitația se va desfășura în conformitate cu *Ghidul Băncii Mondiale pentru Achiziția de bunuri, lucrări și servicii altele decât cele de consultanță*,

în cadrul Împrumuturilor BIRD și creditelor și granturilor IDA, de către Împrumutații Băncii Mondiale, ediția Ianuarie 2011, revizuită în iulie 2014.

Până la data depunerii Ofertelor, companiile interesate de aceasta procedură, au adresat ASD întrebări de clarificare privind Documentele de Licitatie. ASD a răspuns la aceste clarificări care, ulterior, au fost publicate pe pagina oficială a Î.S. „Administrația de Stat a Drumurilor”, www.asd.md, și transmise în adresa operatorilor economici interesați.

Deschiderea Ofertelor

Reprezentanții ASD au deschis Ofertele depuse până la termenul limită, în prezența membrilor Comitetului de Evaluare, invitaților și reprezentanților ofertanților. Deschiderea s-a desfășurat în baza numărului de înregistrare a Ofertelor primite, în ordinea recepționării acestora.

Nici un Ofertant nu și-a retras Oferta și nici nu au fost înregistrate careva substituiri sau modificări a Ofertelor depuse inițial, înainte de deschidere.

Public Bid Opening

Following the launch of the public Bid No.LRIP/W4/01-04 and publication of Invitation for Bidders, 21 companies (Annex no. 5) have expressed their interest to participate in the bidding procedure, consequently, they have been sent the Bidding Documents.

On March 15, 2019, 16:05 pm, (local time), at S.E. State Road Administration (SRA) headquarters, the Opening of the Bids submitted before the established deadline, i.e. 16:00 am (local time), has been held.

SRA's representative has presented the members of the Evaluation Committee, specified the purpose of the session and mentioned that the bidding procedure is carried out in accordance with the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, ed. January 2011, revised in July 2014.

By the established deadline for submission of Bids, the companies interested in the bidding procedure, have requested clarifications regarding the Bidding Documents. SRA responded to those clarifications, publishing them on the official web page of SE "State Road Administration" www.asd.md, and sending them to prospective bidders by email.

Opening of the Bids

The SRA's representatives opened the Bids submitted before the deadline, in the presence of the Evaluation Committee members, invitees and Bidder's representatives, based on registration numbers given to bidders, in order in which they have been received.

Modifications and withdrawals of Bids before opening of the Bids have not been registered.

The Bid Opening Checklists, containing such information as the Bidder's prices, offered discounts, Bid Securities, etc., are filled in and thereafter signed both by the SRA's representative and the bidder's representatives (refer to the Annexes no. 1 and 4). The presence of bidder's representatives is also recorded in a separate register of attendance signed by them (Annex no.3).
