### **PREFACE**

The Government of Moldova, represented by the Ministry of Transport and Road Infrastructure (MTRI), is implementing a **Road Sector Program Support Project** (the **Project**) to be financed by the European Bank for Reconstruction and Development (EBRD), European Investment Bank (EIB) and European Commission (EC). The project is in direct support of the Government's overall Road Sector Program. The works contracts under the Project will be financed through separate financing agreements signed between the Government of Moldova on one side, and IDA, EBRD and EIB on the other

The contracting authority for the project shall be the *State Road Administration (SRA)* within the Ministry of Transport and Road Infrastructure of the Republic of Moldova. SRA's responsibilities include: procurement, financial management, contract management, project and program monitoring and evaluation, and reporting.

This prequalification document and the tender documents which will be issued in due course for the procurement of rehabilitation works under four contracts follow the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004 (revised October 2006) and format and text of the Standard Bidding Documents.

The Works have been divided into four separate contracts:

- Contract **RSPSP/W2/02**: "Rehabilitation of M2 Chisinau-Soroca road km 26+200 km 54+850" *Financed out of proceeds of the EBRD Loan*.
- Contract **RSPSP/W2/03**: "Rehabilitation of M2 Chisinau-Soroca road km 54+850 km 71+165" *Financed out of proceeds of the EIB Credit.*
- Contract **RSPSP/W2/04**: "Rehabilitation of R3 Chisinau-Hincesti road km 22+000 km 29+920"
  - Financed out of proceeds of the EIB Credit.
- Contract **RSPSP/W2/05**: "Rehabilitation of R14 Balti-Sarateni road km 38+300 km 43+000" *Financed out of proceeds of the EC Trust Fund administered by the World Bank.*

It is the intention of this prequalification to qualify applicants for the award of one, two, three, or all four of the proposed contracts. Only qualified applicants from this prequalification process will be invited to bid for the Works.

### **Section I. Instructions to Applicants**

#### A. General

## 1. Scope of Application

1.1 In connection with the Invitation for Prequalification indicated in Section II, Prequalification Data Sheet (PDS), the Employer, as defined in the **PDS**, issues this Prequalification Document (PQD) to applicants interested in bidding for the works described in Section VI, Scope of Works. The number of contracts and the name and identification of each contract, and the International Competitive Bidding (ICB) number corresponding to this prequalification, are provided in the **PDS**.

### 2. Source of Funds

2.1 The Borrower or Recipient (hereinafter called "Borrower") indicated in the **PDS** has applied for or received financing (hereinafter called "funds") from the International Bank for Reconstruction and Development or the International Development Association and from the European Bank for Reconstruction and Development and from the European Investment Bank (hereinafter called individually or collectively "the Bank") towards the cost of the project named in the **PDS**. The Borrower intends to apply a portion of the funds from each of these agencies to eligible payments under the contract(s) resulting from the bidding for which this prequalification is conducted.

### 3. Fraud and Corruption

- 3.1 It is the Bank's policy to require that Borrowers (including beneficiaries of Bank loans), as well as bidders, suppliers, and contractors and their subcontractors under Bank-financed contracts, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Bank:
  - (a) defines, for the purposes of this provision, the terms set forth below as follows:
    - (i) "corrupt practice" is the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
    - (ii) "fraudulent practice" is any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;

In this context, any action taken by a bidder, supplier, contractor, or a sub-contractor to influence the procurement process or contract execution for undue advantage is improper.

<sup>&</sup>quot;another party" refers to a public official acting in relation to the procurement process or contract execution]. In this context, "public official" includes World Bank staff and employees of other organizations taking or reviewing procurement decisions.

a "party" refers to a public official; the terms "benefit" and "obligation" relate to the procurement process or contract execution; and the "act or omission" is intended to influence the procurement process or contract execution.

- (iii) "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
- (iv) "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
- (v) "obstructive practice" is
  - (aa) deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
  - (bb) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under sub-clause 3.1 (e) below.
- (b) will reject a proposal for award if it determines that the bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for the contract in question;
- (c) will cancel the portion of the loan allocated to a contract if it determines at any time that representatives of the Borrower or of a beneficiary of the loan engaged in corrupt, fraudulent, collusive, or coercive practices during the procurement or the execution of that contract, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur;
- (d) will sanction a firm or individual, including declaring ineligible, either indefinitely or for a stated period of time, to be awarded a Bank-financed contract if it at any time determines that the firm has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for, or in executing, a Bank-financed contract; and
- (e) will have the right to require that a provision be included in bidding documents and in contracts financed by a Bank loan,

a "party" refers to a participant in the procurement process or contract execution.

requiring bidders, suppliers, and contractors and their subcontractors to permit the Bank to inspect their accounts and records and other documents relating to the bid submission and contract performance and to have them audited by auditors appointed by the Bank.

## 4. Eligible Applicants

- 4.1 An Applicant shall be a private, public or government owned legal entity, subject to ITA 4.8, or any combination of them in the form of association(s) including Joint Venture (JV) with the formal intent, as evidenced by a letter of intent), to enter into an agreement or under an existing agreement. In the case of a JV, unless otherwise specified in the **PDS**, (i) all parties shall be jointly and severally liable, and (ii) there shall be no limit on the number of partners.
- 4.2 The eligibility criteria listed in this Clause 4 shall apply to the Applicant, including the parties constituting the Applicant, i.e., its proposed partners, subcontractors or suppliers for any part of the Contract including related services.
- 4.3 An Applicant may have the nationality of any country, subject to the restrictions pursuant to sub clause 4.11. An Applicant shall be deemed to have the nationality of a country if the Applicant is a citizen, or is constituted, incorporated or registered and operates in conformity with the provisions of the laws of that country, as evidenced by its Articles of Incorporation or Documents of Constitution, and its Registration Documents.
- 4.4 Applicants and all parties constituting the Applicant shall not have a conflict of interest. Applicants shall be considered to have a conflict of interest, if they participated as a consultant in the preparation of the design or technical specifications of the Works that are the subject of this prequalification. Where a firm, or a firm from the same economic or financial group, in addition to consulting, also has the capability to manufacture or supply goods or to construct works, that firm, or a firm from the same economic or financial group, cannot normally be a supplier of goods or works, if it provided consulting services for the contract corresponding to this prequalification, unless it can be demonstrated that there is not a significant degree of common ownership, influence or control.
- 4.5 An Applicant shall submit only one application in the same Prequalification process, either individually as an Applicant or as a partner of a joint venture. No Applicant can be a subcontractor while submitting an application individually or as a partner of a joint venture in the same Prequalification process. A Subcontractor in any application may participate in more than one application, but only in that capacity. An Applicant who submits, or participates in, more than one application will cause all the applications in which the Applicant has participated to be disqualified.

- 4.6 A firm that has been determined to be ineligible by the Bank in relation to the Bank Guidelines On Preventing and Combating Fraud and Corruption in Projects Financed by IBRD Loans and IDA Credits and Grants shall be not be eligible to be awarded a contract.
- 4.7 An Applicant that is under a declaration of ineligibility by the Bank in accordance with ITA 3, at the date of submission of the application or thereafter, shall be disqualified. The Bank maintains a list of firms and individuals that have been sanctioned by the Bank pursuant to Sub-Clause 3.1 (c) and are not eligible to participate in procurement financed by the Bank. The list is regularly updated; its address is specified in the **PDS**.
- 4.8 Government-owned entities in the Employer's Country shall be eligible only if they can establish that they are legally and financially autonomous, and operate under commercial law, and that they are not dependent agencies of the Employer.
- 4.9 Applicants shall not be under execution of a Bid–Securing Declaration in the Employer's Country.
- 4.10 Applicants and all parties constituting the Applicant shall provide such evidence of their continued eligibility satisfactory to the Employer, as the Employer shall reasonably request.
- 4.11 Applicants from an eligible country may be excluded if, (a) as a matter of law or official regulations the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of goods or the contracting of works required; or (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of goods or contracting of works or services from that country, or any payments to persons or entities in that country. Section VI, Eligible countries provide lists of ineligible countries pursuant to this Sub Clause 4.11.
- 5. Eligible Goods and Related Services
- 5.1 All goods and related services to be supplied under the Contract to be financed by the Bank shall have as their origin in any country in accordance with Section V, Eligible Countries.

### **B.** Contents of the Prequalification Document

- 6. Sections of Prequalification

  Document
- 6.1 The document for the prequalification of Applicants (hereinafter "prequalification document") consists of parts 1 and 2 which comprise all the sections indicated below, and should be read in conjunction with any Addendum issued in accordance with ITA 8.

- Section I. Instructions to Applicants (ITA)
- Section II. Prequalification Data Sheet (PDS)
- Section III Qualification Criteria and Requirements
- Section IV. Application Forms
- Section V. Eligible Countries

#### **PART 2 Works Requirements**

- Section VI. Scope of Works
- 6.2 The "Invitation for Prequalification Applications" issued by the Employer is not part of the prequalification document. A sample form is provided as an attachment to this Prequalification Document for information only.
- 6.3 The Employer accepts no responsibility for the completeness of the prequalification document and its addenda unless they were obtained directly from the Employer.
- 6.4 The Applicant is expected to examine all instructions, forms, and terms in the Prequalification Document and to furnish all information or documentation required by the Prequalification Document.
- 7. Clarification of Prequalification

  Document
- 7.1 A prospective Applicant requiring any clarification of the Prequalification Document shall contact the Employer in writing at the Employer's address indicated in the **PDS**. The Employer will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline for submission of applications. The Employer shall forward copies of its response to all applicants who have acquired the prequalification document directly from the Employer including a description of the inquiry but without identifying its source. Should the Employer deem it necessary to amend the prequalification document as a result of a clarification, it shall do so following the procedure under ITA 8 and in accordance with the provisions of ITA 17.2.
- 8. Amendment of Prequalification Document
- 8.1 At any time prior to the deadline for submission of applications, the Employer may amend the Prequalification Document by issuing addenda.
- 8.2 Any addendum issued shall be part of the Prequalification Document and shall be communicated in writing to all who have obtained the prequalification document from the Employer.
- 8.3 To give prospective Applicants reasonable time to take an addendum into account in preparing their applications, the Employer may, at its discretion, extend the deadline for the

submission of applications.

### C. Preparation of Applications

## 9. Cost of Applications

9.1 The Applicant shall bear all costs associated with the preparation and submission of its application. The Employer will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification process.

## 10. Language of Application

10.1 The application as well as all correspondence and documents relating to the prequalification exchanged by the Applicant and the Employer, shall be written in the language specified in the **PDS**. Supporting documents and printed literature that are part of the application may be in another language, provided they are accompanied by an accurate translation of the relevant passages in the language specified in the **PDS**, in which case, for purposes of interpretation of the application, the translation shall govern.

# 11. Documents Comprising the Application

- 11.1 The application shall comprise the following:
  - (a) Application Submission Form, in accordance with ITA 12;
  - (b) documentary evidence establishing the Applicant's eligibility to prequalify, in accordance with ITA 13;
  - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 14; and
  - (d) any other document required as specified in the **PDS**.
- 12. Application Submission Form
- 12.1 The Applicant shall prepare an Application Submission Sheet using the form furnished in Section IV, Application Forms. This Form must be completed without any alteration to its format.
- 13. Documents
  Establishing
  the Eligibility
  of the
  Applicant
- 13.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Form and Forms ELI (eligibility) 1.1 and 1.2, included in Section IV, Application Forms.
- 14. Documents
  Establishing
  the
  Qualifications
  of the
  Applicant
- 14.1 To establish its qualifications to perform the contract(s) in accordance with Section III, Qualification Criteria and Requirements, the Applicant shall provide the information requested in the corresponding Information Sheets included in Section IV, Application Forms.

# 15. Signing of the Application and Number of Copies

- 15.1 The Applicant shall prepare one original of the documents comprising the application as described in ITA 11 and clearly mark it "ORIGINAL". The original of the application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant.
- 15.2 The Applicant shall submit copies of the signed original application, in the number specified in the **PDS**, and clearly mark them "COPY". In the event of any discrepancy between the original and the copies, the original shall prevail

### **D. Submission of Applications**

# 16. Sealing and Identification of Applications

- 16.1 The Applicant shall enclose the original and the copies of the application in a sealed envelope that shall:
  - (a) bear the name and address of the Applicant;
  - (b) be addressed to the Employer, in accordance with ITA 17.1; and
  - (c) bear the specific identification of this prequalification process indicated in the PDS 1.1.
- 16.2 The Employer will accept no responsibility for not processing any envelope that was not identified as required.

## 17. Deadline for Submission of Applications

- 17.1 Applicants may always submit their applications by mail or by hand. When so specified in the **PDS**, applicants shall have the option of submitting their applications electronically, in accordance with electronic application submission procedures specified in the **PDS**. Applications shall be received by the Employer at the address and no later than the deadline indicated in the **PDS**. A receipt will be given for all applications submitted.
- 17.2 The Employer may, at its discretion, extend the deadline for the submission of applications by amending the Prequalification Document in accordance with ITA 8, in which case all rights and obligations of the Employer and the Applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.
- 18. Late Applications
- 18.1 Any application received by the Employer after the deadline for submission of applications prescribed in accordance with ITA 17 will be treated as indicated in the PDS.

## 19. Opening of Applications

19.1 Any specific electronic application opening procedures required if electronic submission of applications is permitted pursuant to Sub Clause 17.1 shall be as specified in the **PDS.** Employer shall prepare a record of the opening of applications that shall include, as a minimum, the name of the Applicant. A copy of the record shall

be distributed to all Applicants.

### E. Procedures for Evaluation of Applications

### 20. Confidentiality

- 20.1 Information relating to the evaluation of applications, and recommendation for prequalification, shall not be disclosed to Applicants or any other persons not officially concerned with such process until the notification of prequalification is made to all Applicants.
- 20.2 From the deadline for submission of applications to the time of notification of the results of the prequalification in accordance with ITA 28, any Applicant that wishes to contact the Employer on any matter related to the prequalification process, may do so but only in writing.

## 21. Clarification of Applications

- 21.1 To assist in the evaluation of applications, the Employer may, at its discretion, ask any Applicant for a clarification of its application which shall be submitted within a stated reasonable period of time. Any request for clarification and all clarifications shall be in writing.
- 21.2 If an Applicant does not provide clarifications of the information requested by the date and time set in the Employer's request for clarification, its application may be rejected.
- 22. Responsiveness of Applications
- 22.1 The Employer may reject any application which is not responsive to the requirements of the prequalification document.
- 23. Domestic Bidder Price Preference
- 23.1 Unless otherwise specified in the **PDS**, a margin of preference for domestic bidders shall not apply in the bidding process resulting from this prequalification.
- 24. Subcontractors
- 24.1 Applicants planning to subcontract any of the key activities indicated in Section III, Qualification Criteria, shall specify the activity(ies) or parts of the works to be subcontracted in the Application Submission Form. Applicants shall clearly identify the proposed specialist subcontractors in Forms ELI-1.2 and EXP (experience)-4.2(b) in Section IV. Such proposed specialist subcontractor(s) shall meet the corresponding qualification requirements specified in Section III, Qualification Criteria and Requirements.
- 24.2 At this time, the Employer does not intend to execute certain specific parts of the Works by subcontractors selected in advance by the Employer (Nominated Subcontractors) unless otherwise stated in the **PDS**.

## F. Evaluation of Applications and Prequalification of Applicants

### 25. Evaluation of Applications

- 25.1 The Employer shall use the factors, methods, criteria, and requirements defined in Section III, Qualification Criteria and Requirements to evaluate the qualifications of the Applicants. The use of other methods, criteria, or requirements shall not be permitted. The Employer reserves the right to waive minor deviations in the qualification criteria if they do not materially affect the capability of an Applicant to perform the contract.
- 25.2 Only the qualifications of subcontractors that have been identified in the application may be considered in the evaluation of an Applicant. However, the general experience and financial resources of subcontractors may not be added to those of the Applicant for purposes of prequalification of the Applicant.
- 25.3 In case of multiple contracts, the Employer shall prequalify each Applicant for the maximum number and types of contracts for which the Applicant meets the appropriate aggregate requirements of such contracts, as specified in Section III, Qualification Criteria and Requirements.
- 26. Employer's
  Right to
  Accept or
  Reject
  Applications
- 26.1 The Employer reserves the right to accept or reject any application, and to annul the prequalification process and reject all applications at any time, without thereby incurring any liability to Applicants.
- 27. Prequalification of Applicants
- 27.1 All Applicants whose applications have met or exceeded ("passed") the specified threshold requirements will, to the exclusion of all others, be prequalified by the Employer.
- 28. Notification of Prequalification
- 28.1 Once the Employer has completed the evaluation of the applications it shall notify all Applicants in writing of the names of those applicants who have been prequalified.
- 29. Invitation to Bid
- 29.1 Promptly after the notification of the results of the prequalification the Employer shall invite bids from all the Applicants that have been prequalified.
- 29.2 Bidders may be required to provide a Bid Security or a Bid Securing Declaration acceptable to the Employer in the form and an amount to be specified in the Bidding Documents, and the successful Bidder shall be required to provide a Performance Security to be specified in the Bidding Documents.

## 30. Changes in Qualifications of Applicants

30.1 Any change in the structure or formation of an Applicant after being prequalified in accordance with ITA 27 and invited to bid shall be subject to a written approval of the Employer prior to the deadline for submission of bids. Such approval shall be denied if as a consequence of the change the Applicant no longer substantially meets the qualification criteria set forth in Section III, Qualification Criteria and Requirements, or if in the opinion of the Employer, a substantial reduction in competition may result. Any such changes shall be submitted to the Employer not later than 14 days after the date of the Invitation for Bids.

#### 1. General Project Description

The Government of Moldova, represented by the Ministry of Transport and Road Infrastructure (MTRI), is implementing a **Road Sector Program Support Project** (the **Project**) financed by the World Bank, the European Bank for Reconstruction and Development (EBRD), European Investment Bank (EIB) and European Commission (EC).

Under the second stage of the Project to be implemented during the years 2010-2013 it is planned to launch tenders for the procurement of road rehabilitation works under five contracts (see Scheme no 1):

- Contract RSPSP/W2/01: "Rehabilitation of R14 Balti-Sarateni road km 10+780 km 26+600"
- Contract RSPSP/W2/02: "Rehabilitation of M2 Chisinau-Soroca road km 26+200 km 54+850"
- Contract RSPSP/W2/03: "Rehabilitation of M2 Chisinau-Soroca road km 54+850 km 71+165"
- Contract **RSPSP/W2/04**: "Rehabilitation of R3 Chisinau-Hincesti road km 22+000 km 29+920"
- Contract **RSPSP/W2/05**: "Rehabilitation of R14 Balti-Sarateni road km 38+300 km 43+000"

The works contracts will be financed through separate financing agreements signed between the Government of Moldova on one side, and IDA, EBRD, EIB and EC on the other.

For tendering purposes, the works will be divided into three packages, as described below.

- Package 1. The first package consists of Contract **RSPSP/W2/01** financed out of EU Neighborhood Investment Facility Grant administered by the EBRD. Procurement will be carried out through an open tendering procedure with prequalification as defined in EBRD's Procurement Policies and Rules.
- Package 2. Contract RSPSP/W2/02 financed by the EBRD and Contracts RSPSP/W2/03 and RSPSP/W2/04 financed by the EIB will form three lots in the second package. The procurement will follow World Bank's International Competitive Bidding procedures with prequalification and will be conducted on a slice-and-package basis to maximize the economy and efficiency of the procurement process.

Bidding for both of the above packages will be carried out at the same time.

Package 3. The third package, financed by the EC Multi-Sector Grant administered by the World Bank comprises the Contract RSPSP/W2/05; it will be procured through International Competitive Bidding in accordance with the World Bank's procurement guidelines. The prequalification for this contract will be combined with the prequalification for the package 2. The bidding process will be postponed until after contract award under the first two packages. This approach aims to enhance competition, especially among successful bidders, and obtain the best price for this relatively small contract.

The information regarding sections, funding sources, applicable procurement guidelines, phasing and packaging is given in Table 1 below.

#### 2. Description of the Works

The works comprise the resurfacing and strengthening of existing roads in the central area of Moldova.

The Works have been divided into four separate contracts:

- Contract **RSPSP/W2/02**: "Rehabilitation of M2 Chisinau-Soroca road km 26+200 km 54+850"
- Contract RSPSP/W2/03: "Rehabilitation of M2 Chisinau-Soroca road km 54+850 km 71+165"
- Contract **RSPSP/W2/04**: "Rehabilitation of R3 Chisinau-Hincesti road km 22+000 km 29+920"
- Contract **RSPSP/W2/05**: "Rehabilitation of R14 Balti-Sarateni road km 38+300 km 43+000"

It is anticipated that the bulk of the works will comprise Asphaltic Concrete overlays laid over existing surfacing which will require reshaping by milling off high spots and laying regulating courses to low areas. Additional preparatory works will be required in some areas to deal with heavy cracking in the existing asphalt pavements. Limited sections of the project roads will require complete reconstruction comprising pavement removal, subbase, base and asphalt construction. Other sections will require partial reconstruction to full depth along the edges of the existing pavement where limited edge failures have occurred.

Road widths on all three contracts vary with sections of 6, 4, 3 and two lanes occurring in contracts together with additional climbing lanes in some sections. All the existing roads are of flexible pavement construction with asphalt surfacing on crushed stone base.

In addition to the overlay and pavement reconstruction works there will be a limited amount of minor reparation works to shoulders and side drainage and to structures.

## Contract RSPSP/W2/02: "Rehabilitation of M2 Chisinau-Soroca road km 26+200 – km 54+850"

The contract road section runs from km 26+200 (the intersection of M2 Chisinau-Soroca-Ukrainian boarder road with L439 M 2 — Radeni — Draguseni road) to km 54+585, a spot were the road is narrowing from four to three traffic lanes.

The road section crosses five localities: Orhei town, Peresecina village, Mitoc village, Pelivan village and Cismea village. On the length of about 4 km the road passes Codru woodland.

Overlay thicknesses are a nominal overlay of 40mm throughout with the exception of short sections where a 60mm or 90mm overlay is required. Total area of overlay for the complete contract section is estimated at 500,000 sq.m. and total tonnage of overlay material at 54,000 tons with an additional 46,000 tons of regulating being required.

In addition to these levelling operations the existing surface cracking must be rectified to prevent reflective cracking through the new overlays. Crack rectification will be effected by hot air lancing to a minimum depth of 80mm and crack-filling with approved bituminous mastic material for all cracks with an initial width in excess of 4 mm. For cracks and cracked areas where the crack width is less than 4 mm the surface (about 41 thousands square meters) will be sealed prior to overlay with a suitable stress absorbing membrane interface (SAMI) comprising an approved geotextile material fixed to the underlying road surface, and impregnated with, a bituminous binder.

Structural works comprise remedial works to a total of 8 bridges and a number of minor structures. Bridgeworks include repairs to sidewalks, to embankment protection, minor repairs and modifications to infrastructures and bridge decks, waterproofing and expansion joints to existing bridge decks and various minor remedial works.

No diversion roads are foreseen in this contract and it is expected that the Contractor will execute the whole of the works by using half- or partial-width working.

## Contract RSPSP/W2/03: "Rehabilitation of M2 Chisinau-Soroca road km 54+850 – km 71+165"

The contract road section runs from km 54+585, a spot were the road is narrowing from four to three traffic lanes, to the intersection of M2 Chisinau-Soroca-Ukrainian boarder road with R14 Balti-Sarateni-M2 road at km 71+165.

The road section crosses one locality - Zahareuca village.

Overlay thicknesses are a nominal overlay of 40mm throughout with the exception of short sections where a 60mm, 85mm or 90mm overlay is required. Total area of overlay for the complete contract section is estimated at 250,000 sq.m. and total tonnage of overlay material at 31,000 tons with an additional 11,000 tons of regulating being required.

In addition to these levelling operations the existing surface cracking must be rectified to prevent reflective cracking through the new overlays. Crack rectification will be effected by hot air lancing to a minimum depth of 80mm and crack-filling with approved bituminous mastic material for all cracks with an initial width in excess of 4 mm. For cracks and cracked areas where the crack width is less than 4 mm the surface (about 17 thousands square meters) will be sealed prior to overlay with a suitable stress absorbing membrane interface (SAMI) comprising an approved geotextile material fixed to the underlying road surface, and impregnated with, a bituminous binder.

Structural works comprise construction of a new bridge with the span of 6.0 meters, remedial works to one bridge and a number of minor structures.

Also construction of 800 meters long embankment with the maximum height of 1.9 meters will be required for which a diversion road will be constructed. For the rest of the road section no diversion roads are foreseen and it is expected that the Contractor will execute the works by using half- or partial-width working.

## Contract RSPSP/W2/04: "Rehabilitation of R3 Chisinau-Hincesti road km 22+000 – km 29+920"

The contract road section runs from km 22+000 near the Primavara cafe to the intersection with Hincesti town access road at km 29+920.

The road section does not cross any localities.

This road section is in particularly poor condition with extensive sections of the asphalt surfaced, flexible pavement requiring reconstruction. Reconstructed sections will have a new pavement comprising 100 mm sand layer, 225 mm crushed limestone (or other acceptable) subbase, 225mm of crushed granite base and 125mm of asphalt surfacing in binder and

wearing course layers.

Overlay thicknesses vary from nominal overlay of 40mm up to heavy overlay of 150mm. Where the design overlay thickness exceeds 60 mm (i.e. 80mm and above) it is envisaged that the overlay will be placed in two or more layers comprising binder course(s) and a wearing course.

Total asphalt requirement for the whole project is therefore estimated at about 40,000 tons.

In addition to these levelling operations the existing surface cracking must be rectified to prevent reflective cracking through the new overlays. Crack rectification will be effected by hot air lancing to a minimum depth of 80mm and crack-filling with approved bituminous mastic material for all cracks with an initial width in excess of 4 mm. For cracks and cracked areas where the crack width is less than 4 mm the surface (about 12 thousands square meters) will be sealed prior to overlay with a suitable stress absorbing membrane interface (SAMI) comprising an approved geotextile material fixed to the underlying road surface, and impregnated with, a bituminous binder.

Structural works comprise remedial works to a bridge and a number of minor structures. Bridgeworks include repairs to sidewalks, to embankment protection, minor repairs and modifications to infrastructures and bridge decks, waterproofing and expansion joints to existing bridge decks and various minor remedial works.

No diversion roads are foreseen in this contract and it is expected that the Contractor will execute the whole of the works by using half- or partial-width working.

### Contract RSPSP/W2/05: "Rehabilitation of R14 Balti-Sarateni road km 38+300 – km 43+000".

The contract road section runs from km 38+300 at Copaceni village to km 43+000.

The road section passes Copaceni village.

Overlay thicknesses are a nominal overlay of 40mm throughout with the exception of short sections where a 60mm overlay is required. Total area of overlay for the complete contract section is estimated at 47,000 sq.m. and total tonnage of overlay material at 5,000 tons with an additional 4,000 tons of regulating being required.

In addition to these levelling operations the existing surface cracking must be rectified to prevent reflective cracking through the new overlays. Crack rectification will be effected by hot air lancing to a minimum depth of 80mm and crack-filling with approved bituminous mastic material for all cracks with an initial width in excess of 4 mm. For cracks and cracked areas where the crack width is less than 4 mm the surface (about 7 thousands square meters) will be sealed prior to overlay with a suitable stress absorbing membrane interface (SAMI) comprising an approved geotextile material fixed to the underlying road surface, and impregnated with, a bituminous binder.

Structural works comprise remedial works to a total of 3 bridges and a number of minor structures. Bridgeworks include repairs to sidewalks, to embankment protection, minor repairs and modifications to infrastructures and bridge decks, waterproofing and expansion joints to existing bridge decks and various minor remedial works.

On the contract road section a re-construction of a 440 meters long embankment will be required for which a diversion road with the total length of 1.022 km will be constructed. For the rest of the road section no diversion roads are foreseen and it is expected that the Contractor will execute the works by using half- or partial-width working.

The planned Defects Notification Period for all contracts is 1 year.
