and bridge at km 64+756 (Rehabilitation of R6 Chisinau-Orhei-Balti Road km 76+700 –
km 94+700 and bridge at km 72+944)**

1	Should the interested consultants submit one expression of interest for each Lot or should they submit one single expression of interest for both lots?	Consultants should submit one single expression of interest for both lots.
2	Considering that most consultants have implemented relevant road projects (similar to or more complex than this one) in the European Union, following local conditions of contract in line with European Union Directives, which are similar or stricter than FIDIC Conditions of Contract, please clarify if road projects implemented according to European Union countries legislation, embedding European Union Directives, will be accepted.	It is reiterated the importance that the “Experience of the consultant specific to the assignment” should be Supervision of the works under FIDIC conditions of Contract and the requirement shall not be interpreted broader.
3	Is it needed to submit the CVs of the Key experts at this stage?	Consultants should not submit the CVs of the Key experts at this stage.
4	In the paragraph which gives instructions for the needed information in order to describe the company profile, on the third bullet is mentioned: <i>Name, qualifications and relevant experience of firm's director or manager who will assume overall responsibility for the firm's, association's or joint venture's team coordination, management and output</i> ; On table 1 on the other side, on technical and administrative capacity field it is obligatory to write the <i>relevant managerial capacity of the Project Coordinator (CV)</i> , a position that it is not required in the team of the Key experts. Is it possible to clarify what you request in both cases?	<p>For the description of the Company profile, the Expression of interest shall include the CV of the proposed director or manager, who will assume overall responsibility for the firm's, association's or joint venture's team coordination, management and output.</p> <p>The role of such Project Coordinator shall be to liaise with the Client on the Consultant's contractual and administrative matters, and not related to day-to-day activities.</p> <p>Such position is not intended to form part of and shall be distinct of the team of experts which will be deployed in the filed/on site and shall have no direct involvement in the matters of works contract and communication and liaison with the Contractor.</p>
5	Is “similar” addressing the Supervision of Road Works, or general civil Supervision Work (e.g. Railway, Office Building)?	“Similar” refers to the Supervision of Road and/or Bridge Works.
