This amendment is issued with the purpose to mitigate the exceptional circumstances which have arisen due to Covid-19 outbreak in order to facilitate submission of bids and avoid delays in delivery when using post or courier services and exclude face-to-face meetings due to travel restrictions and potential spread of Covid-19.

Bidders shall carefully consider these modifications in conjunction with other provisions of BDs and note that the initially intended procedures for submission, preparation and opening of bids are prevailing and additional submissions of encrypted copies are intended to allow opening and reading of prices one at a time as required under ITB 25.3.

In addition to one original and one copy of bid in hard, the Bidders shall submit one encrypted file in pdf format containing only the scanned, signed copies of Letter of Bid, Priced Bills of Quantities and Bid Security. The encrypted pdf file shall be submitted to the email address specified in Article II of this amendment before the deadline for submission of bids specified in Bid Data Sheet ITB 22.1 and Employer shall issue confirmation of receipt.

Upon request, Bidders shall provide confirmation from courier and post office that the Bids were submitted before submission deadline.

The password for accessing the encrypted pdf file shall be submitted upon Employer's request only to the email which will be provided to Bidders during bids opening session.

Opening of bids will be performed online and Employer will invite all Bidders via email providing access instructions for remote connection. The instructions for public access and access link will be published on SRA web site prior to the deadline for submission of Bids.

When preparing their Bid Securities, Bidders shall consider that Bids submission deadline was extended through the Amendment No.3 issued on 27 April 2020 and as provided under ITB 18.2 the Bid Security shall also be extended for twenty-eight (28) days beyond the deadline of the extended validity period.
