Contract Description:

Corridor 8.3 lies in Calarasi district and is a linking road between R21 Road (R20 – Codru sanatorium) and L 376 Road (Cornesti-Boghenii Noi-Radeni-Hoginesti). Corridor 8.3 runs through three localities: Hirbovet, Sverida and Oniscani. Total length of the Corridor is 9.9 km, 5.9 km of which are outside localities and 4 km of which run through villages. There are two patterns of existing road pavement: one of crushed stone and the other of asphalt concrete. The main prevailing defects are: transverse and longitudinal cracks, rutting, blocks of cracks and alligator cracks, undulations, raveling and damaged edges. There are 13 existing culverts on this Corridor, some of them shall be repaired, the 5 other shall be replaced; there is also one existing bridges which shall be repaired. Traffic safety shall be improved through construction of intersections, installation of road signs, metallic parapets, marker posts and road marking.
