The Ministry of Economy and Infrastructure has received financing from the World Bank toward the cost of the Local Roads Improvement Project, and intends to apply part of the proceeds toward payments under the contract the upgrading and maintenance works on the Local Road L405 R21 - Oniscani (km 0+000 to km 9+962).

2. The Ministry of Economy and Infrastructure represented by the I.S. “Administratia de Stat a Drumurilor” now invites sealed bids from eligible bidders for Works for “Improvement of the Local Road Corridor 8.3, L405 Road from R21 – Oniscani, km 0+000 to km 9+962” inclusive of all the necessary road improvement activities such as earthworks, road pavement rehabilitation/widening, repair works to structures, intersections, structures, drainage, incidental and safety facilities, road marking, signing and sidewalks, rearrangement of engineering services, etc.

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank’s Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, Ed. January 2011, revised July 2014 (“Procurement Guidelines”), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest.
