The Ministry of Economy and Infrastructure has received financing from the World Bank toward the cost of the Local Roads Improvement Project, and intends to apply part of the proceeds toward payments for Improvement Works on Corridor 11, Contract 1: LRIP/W3/01: “L313 M2 – access road to Miclesti village (km 0+000 to km 5+000) and L314 M2 – Peresecina, Hirtopul Mare – Ohrincea (km 1+640 to km 15+390)”; and Contract 2: LRIP/W3/02: “L314 Bypass road Izbiste (km 15+390 to km 19+810) and L314 M2 – Peresecina – Hirtopul Mare – Ohrincea road (km 19+810 to km 24+300)” .

1. The Ministry of Economy and Infrastructure represented by the I.S. “Administratia de Stat a Drumurilor” now invites sealed bids from eligible bidders for Works for “Improvement of the Local Road Corridor 11, Contract 1: LRIP/W3/01: “L313 M2 – access road to Miclesti village (km 0+000 to km 5+000) and L314 M2 – Peresecina Hirtopul Mare – Ohrincea (km 1+640 to km 15+390); and Contract 2: LRIP/W3/02: “L314 Bypass road Izbiste (km 15+390 to km 19+810) and L314 M2 – Peresecina – Hirtopul Mare – Ohrincea road (km 19+810 to km 24+300)” inclusive of all the necessary road improvement activities such as earthworks, road pavement rehabilitation/widening, repair works to structures, intersections, structures, drainage, incidental and safety facilities, road marking, signing and sidewalks, rearrangement of engineering services, etc.

2. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.

4. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank’s Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers Ed. January 2011, revised July 2014 (“Procurement Guidelines”), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest.
