Mr. Mircea Dobînda has continued the presentation on the scope of works and has made a brief overview on the geometrical parameters of the roads, major structural works and main estimated quantities for the respective works contract.

Questions and Answers:

Mr. Serghei Polisciuc requested Contractor's representative to address their questions. Attendees have raised their questions and some of them were further discussed and answered in general lines. Mr. Serghei Polsciuc has specified that all the questions will be formally answered through the
