

**Minutes of the Evaluation Committee session for public
opening of the financial proposals for the Technical Audit services, No. SC8**

As a result of the examination of technical proposals, the firms have accumulated the following technical scores:

Glocoms, Inc. (USA)	70.0
SAFEGE Consulting Engineers (France) with IRD Engineering (Italy)	68.7

Due to the fact that the following firms: High-Point Rendel (UK) with Depar (Turkey), Glocoms, Inc. (USA), SAFEGE Consulting Engineers (France) with IRD Engineering (Italy) did not accumulate the minimum qualifying score of 80 points, their financial proposals will not be opened and will be returned unopened after the contract signing with the winning consultant.

No objection for the Technical proposals evaluation report was issued by the World Bank on November 1, 2007.

Invitation for attendance of the Financial Proposals public opening session was sent to the firms which secured the minimal qualifying scores on November 5, 2007.

The Financial Proposals of the firms which have secured the minimum qualifying score of 80 points have been submitted at the following prices:
