Article 1

Tender Documentation, Bill of Quantities, BILL 000, the Item 00402 has been deleted and substituted with the new Item 00402, Tender Documentation, Bill of Quantities, BILL 000, as follows:

Article 2

Particular Conditions of Contract (PCC) – Part B, Sub-Clause GCC 8.1 [Commencement of Works] shall be deleted entirely and replaced with the following:

	Delete the entire Section 8.1 [Commencement of Works] of the General Conditions of Contract and replace with the following:
	Except as otherwise specified in the Particular Conditions of Contract, the Commencement Date shall be the date at which the following precedent conditions are evidenced in writing as being fulfilled:
	8.1 (a) Signature of the Contract Agreement by both parties; (Copy of signed Contract Agreement)
	8.1 (b) Possession of the Site given to the Contractor together with such permission(s) under Sub-Clause 1.13 [Compliance with Laws] as required for the commencement of the Works, including the Construction Permit, provided that the Contractor has presented to the Employer, within 42 days after receiving the Letter of Acceptance; (Evidenced by copy of Employers letter giving Possession of Site (GCC 2.1) and copy of Construction permit (GCC 1.13) and any other required permissions).
	8.1 (c) Submission by the Contractor of an acceptable Advance Payment Guarantee (where required by the Contractor), and any other document (if the case) required from Contractor not later than 28 calendar days after the signing of the Contract Agreement, and confirmation of the preparation and processing of an IPC for payment of the Advance Payment by the Employer. (Evidenced by copy of Guarantee and IPC).
	If the submission for an Advance Payment (in acceptable format) is not received within 28 calendar days after signing of the Contract

Agreement precedent condition 8.1 (c) shall be considered void and only points 8.1 (a) and 8.1 (b) shall be applicable in relation to the issue of the Notice to Commence.
The Engineer, if satisfied that points 8.1 (a) and 8.1 (b) and 8.1(c) are fulfilled, (where 8.1(c) is applicable) shall then proceed to issue the Notice to Commence to Works identifying the Commencement Date of the Contract with copy to all parties.
If the said Engineer's Instruction is not received by the Contractor within 180 days from the date of signing the Contract Agreement, the Contractor shall be entitled to terminate the Contract under Sub-Clause 16.2 [Termination by Contractor].
The Contractor shall commence the execution of the Works as soon as is reasonably practical after the Commencement Date and shall then proceed with the Works with due expedition and without delay.

agreement to the above items of equipment and confirm that they will be mobilizing the nominated equipment to the worksite. **For Example**: Thermoplastic line marking equipment or pile driving may be via specialized sub-contract".
